

# Introduction

The authority delegated in this Manual is delegated by the Chief Executive Officer to Authorised Officers. To avoid confusion with the Delegated Authority Register – Council to Authorised Officers (the Register), this document has been titled Delegated Authority Manual – Chief Executive Officer to Authorised Persons.

The majority of these delegations are first delegated to the Chief Executive Officer by Council and are recorded in the Delegated Authority Register – Council to Authorised Officers. In some cases, authority is directly delegated to Officers by Council, these are primarily recorded in the Delegated Authority Register – Council to Chief Executive Officer, however a copy has been included within this document. Some legislation provides the CEO the power to delegate certain duties without Council endorsement, these are included in this Manual and colour coded orange.

This Manual does not automatically give the Officer holding a listed authorised position delegated authority. Powers are conferred to Officers by the Chief Executive Officer through the issuance of an Instrument of Delegation. These are issued and reviewed on an annual basis following the review of the Register and this Manual.

There are three colours used throughout this Manual to highlight different statutory requirements. Their meanings are listed below.



Authority has been delegated to the CEO to appoint Authorised Officers. This cannot be sub-delegated.

Authority has been directly delegated to Authorised Officers by Council.

Authority has been delegated to the CEO by Council and the CEO may sub-delegate to staff.

Authority to delegate duties has been given to the CEO by the relevant Legislation. These are not endorsed by Council.

#### **Record Keeping**

If a person is exercising a delegated power or duty, r.19 of the *Local Government (Administration) Regulations 1996* requires records be kept relating to the exercise of the power or discharge of the duty. The written record is to contain:

- (a) how the person exercised the power or discharged the duty; and
- (b) when the person exercised the power or discharged the duty; and
- (c) the persons or classes of persons, other than council or committee members or employees of the local government, directly affected by the exercise of the power or the discharge of the duty.
