# Creche Agreement Terms and Conditions

The Centre is managed by the Shire of Esperance. ABN: 60 034 434 085.

These are the terms and conditions of the creche agreement (The "Agreement") between you (The "Parent/Guardian") and the Centre.

## Administration

1. A ticket obtained from reception must be presented to crèche on entry.
2. The parent or guardian is required to complete the crèche register. Please inform staff of any special instructions for the care of your child/children.
3. Confirm your child's collection time.
4. Crèche is suitable for children between 8 weeks of age through to 12 years.
5. A child cannot attend for more than 3 hours per session.
6. A child cannot attend for more than 12 hours in a week.
7. I accept that I must stay on the premises while my child attends the crèche.
8. I understand that I am at all times responsible for my child while attending crèche.
9. I understand, if required by staff I must return to my child immediately in crèche.
10. No sick child/children will be allowed to attend crèche. If a child becomes unwell in crèche, you will be required to return immediately.
11. I consent to medical treatment being obtained for my child in an emergency.
12. The Centre as reasonably necessary, with no compensation –
  - a. Change hours of operation.
  - b. Close of any part of the premises or isolate any piece of equipment for maintenance or safety reasons.
  - c. Amend any provision of this Agreement and/or Centre Terms and Conditions from time to time with immediate effect.

Where this occurs, the Centre will endeavor to provide reasonable notice in a manner we deem appropriate.

## Liability

1. By signing the Agreement, you -
  - a. Acknowledge and agree that you release and discharge the Centre from all liability for loss, damage or injury which your child may sustain.
  - b. Indemnify the Centre to the extent permitted by law in respect of any claim by any person arising as a result of or in connection with your creche attendance and/or participation in any of our activities.
  - c. Acknowledge this release and indemnity shall not apply to the extent that the loss, damage or injury which is the subject of the claim is caused, or contributed to, by the negligent act or omission of others.

## Membership Entitlements

1. Complimentary crèche access only applies to Complete Fitness Memberships.
2. Crèche access only applies during operating hours of the crèche.
3. A child cannot attend for more than 2 hours per session under this entitlement. If more time is required, casual fees apply.

4. Complimentary access is limited to 2 children per Complete Fitness Membership. The Complete Fitness member must be immediate family of the child/ren and the responsible member must be present at the Bay of Isles Leisure Centre.
5. Additional children will be charged at regular rates.

Note: Where there is reference to 'immediate family' this refers to: a parent (incl. step parent, foster parent or adoptive parent) or grandparent.
