Food Act 2008 / Food Regulations 2009

- Application must be lodged at least **2 weeks** before an event or it may not be processed.
- Community, charity or fundraising selling low risk, shelf stable or potentially hazardous food cooked onsite for immediate consumption (e.g. sausage sizzle) is exempt from fees.

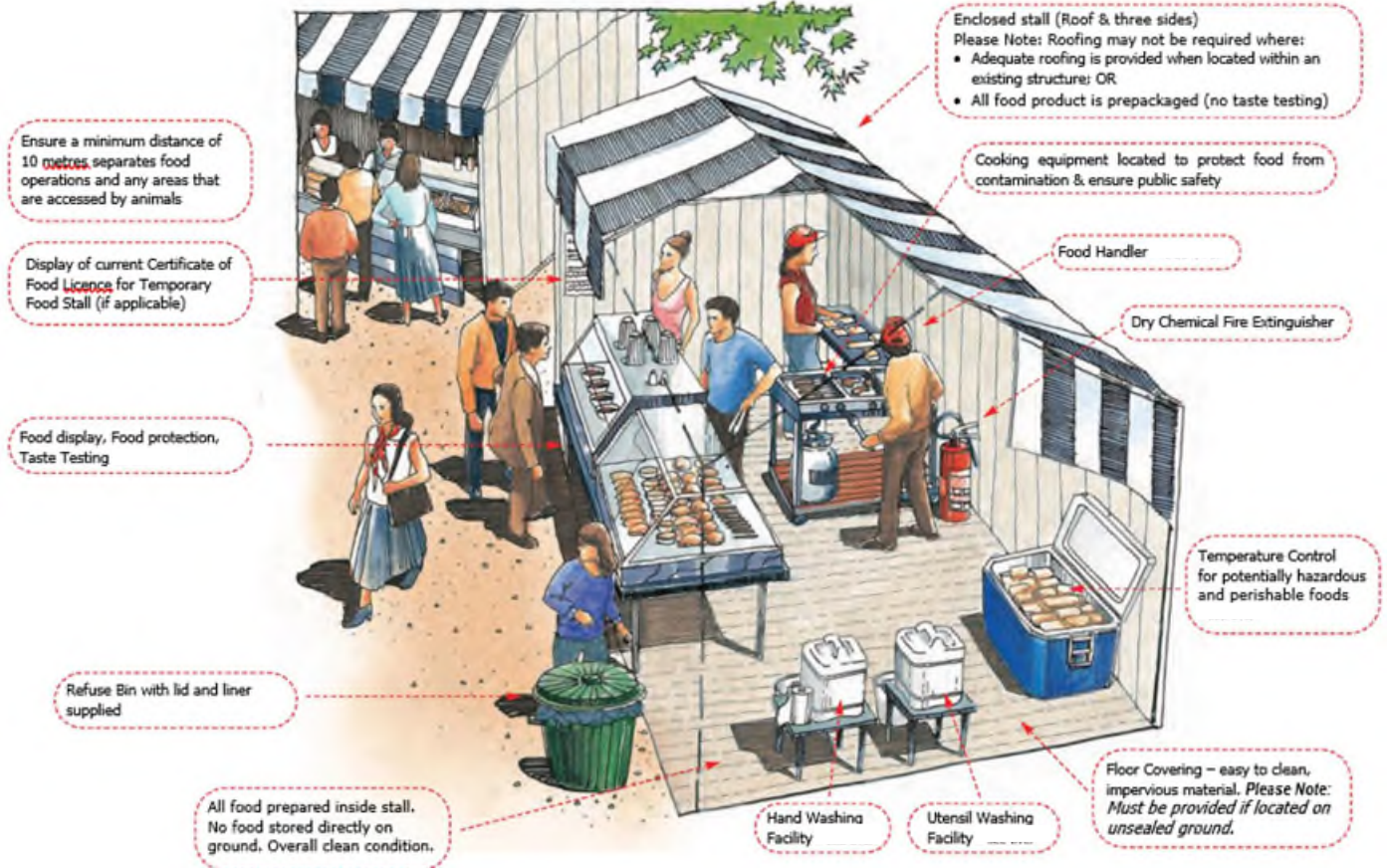
